
## **Old Business:**

#### **New Business:**

- Discipline for multiple infractions at Arcadia: The Board has approved a motion to suspend a Vintage member at all fields for 30 days for repeatedly ignoring the rules at Arcadia Park. A subsequent infraction will result in a suspension for a minimum of 90 days. Ignoring Park rules and/or City laws puts all Vintage Club members in jeopardy of losing our privilege of using the fields.
- Review of 1 Pitch Tournament: This year's tournament turned out great and was a big hit with our Members! The Club paid for all expenses! Thank you to all who came out to have a good time!
- Holiday Party Update: This year's Holiday Party will be held on Sunday, November 19<sup>th</sup> 2023 from 4 to 8PM at Case Lupe in Sunnyvale. More detailed information will be available through a separate email distributed to all Vintage members.



- 2023 Elections Time Frame, Nominations: Jim P. has created the following schedule (subject to change):
  - 10/09/23 -> 10/23/23 Open time to vote for Nomination Phase
  - 11/01/23 -> 11/14/23 Open time to vote for Election Phase
- 2024 Budget: Technically, the Club made \$5,000 dollars this year, but it was due to unexpected, probably one-time savings on field costs. If everything goes well the Club can expect to lose \$1,990 next year. If all does not go so well such as field price increases, equipment prices go up, etc. next year the Club could lose \$3,000 to \$7,000. However, given the surplus we had last year, the Board rejected a motion to increase dues in 2024. The Board approved the 2024 Budget with no increase in dues.
